MEMORANDUM OF ASSOCIATION

1. Name:

The name of the Society shall be CHITTARANJAN PARK KALI MANDIR SOCIETY and henceforth be mentioned as "SOCIETY".

2. Location:

The registered office of the Society shall be located at Mandir Complex, Chittaranjan Park, New Delhi-110019.

3. Aims and objects:

The aims and objects of the Society shall be :-

- to make proper arrangements for daily worship of Kalimata, Shivalinga and Radha-Krishna in the traditional manner and in accordance with the Shastric injunctions;
- to arrange special and seasonal worship of Kalimata, Durgamata and other Gods and Goddesses in accordance with the Shastric injunctions;
- to arrange any other Puja or religious celebration as may be decided by the Managing Committee from time to time;
- to maintain Dharmashala and to provide temporary shelter in its premises to any person on request for such shelter subject to the conditions prescribed by the Managing Committee, provided that no such shelter shall be given to any person who, in the opinion of the Managing Committee or its competent authority, has acted or likely to act against the interests of the Society;
- to acquire land in Chittaranjan Park, New Delhi for the Society and to construct Mandir, Dharmashala, buildings, etc., thereon;
- to raise funds for the furtherance of aims and objects of the Society;
- to organise relief operations amongst people without

distinction of caste, creed or religion in times of natural calamities etc.;

- (h) to establish charitable health centre and undertake other welfare and charitable activities as may be approved by the Managing Committee from time to time;
- (i) to raise poor fund/relief fund and render assistance to any individual in need or to any organisation engaged in religious, social, cultural, educational or humanitarian services;
- (j) to provide accommodation in the Dharmashala or in any other premises of Kali Mandir Complex, to any organisation engaged in religious, social, literary, artistic or cultural activity which, in the opinion of the Managing Committee, may be conducive to the welfare of the Society;
- (k) to promote religious, social, literary, artistic and cultural activities;
- (l) to maintain a library and a free reading room in the Mandir premises on such conditions as may be prescribed by the Managing Committee or any competent authority responsible to the Managing Committee from time to time;
- (m) to co-operate with or help other organisations, societies, clubs, institutions engaged in cultural, social, religious, educational and welfare activities and humanitarian services;
- (n) to provide facilities for training in yogic practices, sports and physical exercises as may be approved by the Managing Committee from time to time;
- (o) to perform such other allied functions and undertake such other Social and non political activities as may contribute to or further the above mentioned aims and objects of the Society.

4, Availability of Services and Facilities :

The Mandir (s), Dharmashala, religious, educational, welfare, humanitarian and charitable activities and functions etc. shall be open to all.
